1 annual scholarship worth € 2,406.00 (subject to tax and social security deductions as provided for by law) is hereby established, reserved for deserving students who will enrol in the 2022/2023 academic year in the first year of the undergraduate programme in Food Production Management at the Faculty of Agriculture, Food, and Environmental Sciences of Università Cattolica del Sacro Cuore, activated at the Piacenza Campus.

In order to take part, students must have obtained a high school diploma with a mark of no less than 85/100 and have an "equivalent" income, determined on the basis of their tax return for the 2021 tax year (as set out in the "General regulations for determining university fees - academic year 2022/2023 - Università Cattolica del Sacro Cuore") of no more than € 100,000.00.

Students wishing to compete for the scholarship must submit the following documents on plain paper:

- application for participation in the competition addressed to the Rector of Università Cattolica. The application must include personal details, date and place of birth, domicile, telephone number, e-mail address and tax code, as per the attached facsimile;
- motivation letter, as per the attached facsimile;
- self-certification of high school graduation grade from the secondary school attended;
- self-certification of enrolment for the academic year 2022/2023 in the first year of the undergraduate programme indicated above.

The documentation MUST BE RECEIVED by the Campus Administration – Directorate at Università Cattolica del Sacro Cuore - Via E. Parmense, 84 - 29122 Piacenza - email: direzione.sede-pc@unicatt.it - <u>BY 13 FEBRUARY 2023</u>. APPLICATIONS RECEIVED/DELIVERED AFTER THIS DEADLINE WILL NOT BE ACCEPTED.

The allocation of the scholarships will be made at the sole discretion of the special Commission appointed by the Rector on the basis of an initial ranking drawn up on the basis of merit criteria, the evaluation of the documentation listed above and, only where conditions are equal, on the basis of a motivational interview and household income.

The scholarship is incompatible with other awards or scholarships received by the student in the same academic year.

Please note that it is possible to apply for both the present call and the EDUCatt scholarship call. However, applications from students who, as at 31 December 2022, are ELIGIBLE in the EDUCatt ranking list will not be considered.

The amount of the grant will be paid upon verification of regular enrolment in the **first year** of the programme.

Tax treatment of the scholarships: the scholarships awarded are subject, for tax purposes, to the regulations in force regarding scholarships. The sum paid is income assimilated to that of employees and therefore has the same tax treatment.
