



SCHOLARSHIPS 'FONDAZIONE INVERNIZZI' ACADEMIC YEAR 2023/2024

Four scholarships worth € 2,406.00 are awarded for the following graduate degree programme of the Faculty of Agriculture, Food and Environmental Sciences of the Cremona campus of Università Cattolica del Sacro Cuore:

- Food processing: innovation and tradition

reserved for European students of non-Italian nationality holding a foreign qualification who intend to enrol, for the academic year 2023/2024, in the first year of the above-mentioned degree programme.

The winner of this call for applications must have acquired, by 31 October 2024, 36 ECTS with an average mark of no less than 26/30 in order to be eligible for the scholarship in the second year of the degree course.

Students wishing to apply for the scholarship must submit the following documents:

- copy of the transcript with grades of the undergraduate degree.
- application for participation in the competition addressed to the Rector of Università Cattolica. The application must contain personal details, date and place of birth, address, telephone number, e-mail address and, if available, tax code (attached);
- self-certification attesting graduation (degree programme, grade and date of graduation);
- self-certification of enrolment in the a.y. 2023/24 in the first year of the above-mentioned graduate degree programme;
- cover letter, as per the attached facsimile;
- curriculum vitae.

The documentation must reach the Campus Administration Directorate - Università Cattolica del Sacro Cuore - Via E. Parmense 84 - 29122 Piacenza - email: direzione.sede-pc@unicatt.it - by 29 June 2023.

The award of the scholarship will be made at the sole discretion of the special Commission appointed by the Rector on the basis of merit criteria.

The scholarship is incompatible with other awards or scholarships received by the student in the same academic year, including the scholarship provided by EDUCatt.

Please note that it is possible to apply for both the present call and the EDUCatt scholarship call. However, applications of students who on 31 December 2023 are deemed suitable (IDONEI) in the EDUCatt ranking list will not be considered.

Tax treatment: the sum paid constitutes income assimilated to employment income and is therefore subject to the same tax treatment.
