- ADDITIONAL TRAINING OBLIGATION (OFA) EXAMINATION:
- The Final Assessment will be held online on **Saturday 15th March 2025 at 9.00 a.m.**
- You will have to register for the Final Examination on your own using the usual registration feature for exam dates available in iCatt within two weeks (from 27 February to 11 March 2025), i.e. no later than four days prior to the date of the Final Examination mentioned above.
 Please note: the system enables registration for the Final Examination only if at least 70% of the lessons have been attended. In addition, for registration to be successful, it is necessary to select the committee chairperson, Professor Amanda Clare Murphy. If the above instructions are not followed, it will not be possible to register for the Final Examination.
- If you wish to forego taking the **Final Examination** and postpone it until the end of a later edition, **you must cancel your registration** no later than the day before the date of the **Final Assessment**.
