Program Cost:

- Approximately \$15,500 USD for tuition and fees (tuition may be reduced depending on size of cohort) Example: 2-4 students: \$13,000 USD / 5+ students: \$11,000 USD
- Approximately \$20,000 USD for estimated living expenses (January-August)

Eligibility Requirements:

- Complete the Universitá Cattolica del Sacro Cuore courses with a cumulative grade point average of "B" (3.0)
- GMAT not required
- Satisfy the English language proficiency requirement with a passing:
 - o TOEFL (80 ibt) or,
 - o IELTS (6.0 overall score, with a writing section of 6 and no section score below 5.5)
- Receive an MBA degree in International Business upon completion of the program from both California State University San Marcos and Universitá Cattolica del Sacro Cuore
