2.3 Additional Information:

a) Grading System:

Students are graded on a 0 to 20 point scale (minimum passing grade is 10) and according to the ECTS Grading Scale. The ECTS grading scale provides additional information on the rank of a student in a given assessment, i.e., how he/she performed comparatively to other students in the same class (or in a significant group of students. The grades are expressed as follows:
