VISA (IF NECESSARY)

Pace International issues the DS-2019 Certificate of Eligibility for J-1 exchange visitor status. The office also provides information on the process for obtaining a J-1 student visa as well as steps to maintaining lawful J-1 visa status during the program.

Graduate: Minimum 9 US credits per semester

LANGUAGE OF INSTRUCTION & RECOMMENDED LANGUAGE LEVEL

Language of instruction: English

The U.S. Department of State requires J-1 Exchange Visitors to have "sufficient proficiency in the English language, as determined by an objective measurement of English language proficiency, to successfully participate in his or her program and to function on a day-to-day basis." Pace University's minimum admission requirements are: IELTS overall score of 6.5

TOEFL test score must be 550 (paper based) or 80 (internet based)

The test must have been taken within the past two years.

An applicant whose first language is English, who is attending an institution in which the language of instruction is English, or who is a citizen of a country in which English is the primary spoken language of daily life is exempt from this requirement.

HEALTH INSURANCE
