Bachelor's Degree Program (Laurea Triennale) in Economia dei Mercati e degli Intermediari Finanziari (EMIF, general profile)

Program

The program offers students the possibility of obtaining a double degree at its completion: Laurea Triennale from Università Cattolica del Sacro Cuore and Bachelor degree (BSc) in Banking and Finance from Bangor Business School.

The program covers three years of study, with the first and second year at Università Cattolica and the third year at Bangor Business School. The academic year usually starts in September, with an Orientation week for all the students.

Eligible students and how to apply

?

Students enrolled in the second year of Laurea Triennale at the School of Banking, Finance and Insurance Sciences can apply for the program.

Applications must be submitted via the appropriate enrollment procedure by March 8th, 2022 along with the payment of the non-refundable \in 35 application fee.

Minimum requirements

- a minimum weighted average of 24/30;
- a valid TOEFL or IELTS certificate with a score of at least 83 for TOEFL or 6.0 for IELTS (no less than 5.5 in any other section). The IELTS or TOEFL should be passed no more than two years from the closing date of this program;
- complete all the exams by the summer session by July

N.B.: If any of the prerequisite is not satisfied, but the general academic curriculum is good, the ammission will be evaluated on a case by case basis, by Bangor University

Thesis

Students in the program will prepare a final thesis during their exchange period, under the coordinated supervision of both institutions (one member of the academic staff from each institution).

The final thesis will be discussed at Università Cattolica del Sacro Cuore upon return from the exchange period, in accordance with the rules set by the Faculty Board.

Theology

Please note that all students taking part in the Degree program are required, in accordance with Cattolica regulations, to take the Theology exams present in their course plan.



Costs and scholarships



The cost below is tentative, and it will be subject to change as a consequence of Brexit. Updated costs will be available by the end of 2021.

Program fee: £ 13,000

Selected students will be responsible for all costs associated to their time abroad (travel, room and board, registration fees, cost of academic material, health insurance and visa issuance fees).

Selected students must also be officially enrolled at Università Cattolica del Sacro Cuore for the entirety of their time at Bangor (respecting all university set deadlines for fees, study plans, graduation scheduling requests etc.).

Cattolica International will award scholarships of \in 3,000 to eligible candidates, until funds are available.

In case funds will not be enough to ensure a scholarship to each candidate, students will be ranked following academic performance and English proficiency, as stated here below:
