

## NOTICE OF COMPETITION IN MEMORY OF GIOVANNI SPALTRO

### **Introduction**

The following notice has been issued for the 2021/22 academic year: “Notice of competition for the award of a scholarship in memory of Giovanni Spaltro (renewable for two academic years) in the amount of EUR 3,500 (all-inclusive of tax charges) reserved for a student residing outside the Province of Milan and enrolled for the 2021/22 academic year in the first year of the undergraduate degree programme in Economics & Management (Economics track) at the Faculty of Economics of Università Cattolica del Sacro Cuore.

### **Recipients**

The call is open to students residing outside the Province of Milan/ and enrolled in the first year of the undergraduate degree programme in Economics & Management (Economics track) at the Faculty of Economics of Università Cattolica del Sacro Cuore for the 2021/22 academic year.

The scholarship covered by this announcement is targeted towards assisting students of the aforementioned course of study on the basis of progress in their university studies and their family income.

### **Selection board and evaluation criteria**

Evaluation of the candidates and deciding on the winners of the competition will be entrusted to a special panel consisting of two professors from Università Cattolica del Sacro Cuore nominated by the Dean of the Faculty of Economics and by Dr. Marco Spaltro.

The award of the scholarship will be made based on merit to a candidate belonging to the following income brackets:

- students with an income up to EURO 24,000.00;

and in the event that there are not suitable candidates in the above income bracket:

- students with an income between EUR 24,001.00 and EUR 40,000.00.

In the case of equal merit, the candidate with the lowest income will be awarded the scholarship.

Details of the income of the family unit will be acquired through the official documentation declared and certified ex officio at the time of enrolment in the 2021/22 academic year.

The scholarship will be awarded on the basis of the following evaluation criteria:

<b><u>CRITERIA</u></b>	<b><u>WEIGHTING</u></b>
Weighted average of credits for exams passed at the date of the evaluation of the applications	40%
Income	30%
Where the candidate is officially resident	30%

### **How to apply and deadline for submitting applications**

Due to the protracted SARS-CoV-2 health emergency, applications for admission to the competition must be submitted using the application form available on the Università Cattolica del Sacro Cuore website. The completed form, in pdf format, must be emailed to normative.borsestudio@unicatt.it by 28 February 2022, together with self-certification of exams taken with grades, dates, credits and discipline category (self-certification available on personal ICatt pages).

### **How the scholarship funding will be paid**

The scholarship funding will be paid in a lump sum by April 2022. The winners will be notified in writing.

### **Renewal for subsequent years**

The final decision to renew the scholarship for subsequent academic years will be taken by the panel on the basis of the following criteria (no discussion will be entered into):

- a) enrolment on the undergraduate degree programme in Economics & Management (Economics profile) must have been effected for the year the scholarship would be renewed for;
- b) exams in the study plan must have been passed with a minimum weighted grade of 27/30 by the extraordinary session of each academic year for which the scholarship would be renewed;
- c) minimum income referred to in art. 3 must have been maintained for each year for which the scholarship would be renewed.
